Registrant further agrees to release and hold harmless NRCHA, its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependents, and successors in interest. I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the NRCHA Rule Book. I agree as a condition of in consideration of acceptance of entry the National Reined Cow Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA.
